7:00 – The meeting was **called to order**. Nineteen members attended (GK Depuy, Treas. Coker, FS Palmer, Dist. Ward. ## Grand Knight report (Depuy) -

Thanked Steve Gajdos for dinner. Recognized the PGKs (Coker, Palmer, McCaffrey, Mohring), Deacon Frank, and DD John.

Not much to report this month. Events starting to come up over next several months.

**FinSec report (Palmer)** – still collecting dues. 37 of 50 have paid so far. Census is 93 Knights. The remaining 43 include 27 honorary (including priests and deacons), 1 inactive, and 15 other members who are currently on the roll but are neither actively participating nor paying dues.

\$814 in deposits. Major checks include \$1,000 for Special Olympics and Ed McCarron's flowers and Mass cards. \$500 check on donation for Chicken Soup (Souper bowl) that is coming up on February 22-24.

**Treasurer's report (Coker)** – Current account balance of \$33,317.81 decreased by (\$865.13) vs. \$34,182.94 prior month. \$1,214.19 in deposits (primarily 2025 dues) offset by (\$2,079.32) in payments. Major payments included \$1,000.00 Special Olympic Polar Plunge, \$500.00 Souper Bowl donation, and Mass card / flowers for Ed McCarron's funeral. Full detail report is on file online.

No uncleared checks as of the date of report.

6-month CD (3.688% APY) opened in February 2025, matures in August 2025. Additional funds added to the prior rolled-over CD in order to bring the principal to \$15,000.

Semi-annual audit has been completed and is with the GK and trustees. 990 Tax form also filed.
